When a transcript is originally produced, a certified copy must be promptly delivered by the transcriber to the clerk of court concurrent with, but no later than three working days after delivery to the requesting party.

If the transcript is to become the official court record, 28 U.S.C. § 753(b) states: "No transcripts of the proceedings of the court shall be considered as official except those made from the records certified by the reporter or other individual **designated** to produce the record."

The statute, 28 U.S.C. § 753, requires the court to supervise all aspects of the court reporting and transcription process. The court has complete control over who produces an official transcript of court proceedings. While an attorney may have a transcript produced from a certified copy of a sound recording, the transcript will not be an official record suitable for filing with the court unless the court approves it as the official record.

TRANSCRIPT RATES (PER PAGE)

The following rates, as approved by the Judicial Conference of the United States are now in effect.¹

¹ Includes a copy to be filed with the Clerk of Court at no additional charge to the ordering party or the court.

Ordinary Transcript	\$3.65	\$.90	\$.60
14-Day Transcript	\$4.25	\$.90	\$.60
7-Day Transcript	\$4.85	\$.90	\$.60
Daily Transcript	\$6.05	\$1.20	\$.90
Hourly Transcript ²	\$7.25	\$1.20	\$.90

- Ordinary Transcript -

Transcripts to be delivered within thirty (30) calendar days after receipt of an order.

- 14-Day Transcript -

Transcript to be delivered within fourteen (14) calendar days after receipt of an order.

- 7-Day Transcript -

Transcript to be delivered within seven (7) calendar days after receipt of an order.

- Daily Transcript -

Transcript to be delivered following adjournment and prior to the normal opening hour of the court on the following morning, whether or not it actually is a court day.

- Hourly Transcript -

Transcript of proceedings ordered under unusual circumstances, to be delivered within two (2) hours.

² Hourly delivery is generally not available.
